SECTION 605 ELECTRICAL EQUIPMENT, WIRING AND HAZARDS

605.1 Abatement of electrical hazards. Identified electrical hazards shall be abated. Identified hazardous electrical conditions in permanent wiring shall be brought to the attention of the responsible code official. Electrical wiring, devices, appliances and other equipment that is modified or damaged and constitutes an electrical shock or fire hazard shall not be used.

605.2 Illumination. Illumination shall be provided for service equipment areas, motor control centers and

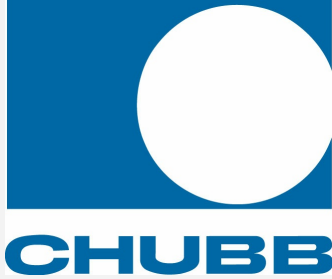


NEW - CENTER MEMBERSHIP FOR STUDENTS

U.S. Fire Administration's Campus Fire Fatalities in Residential Buildings (2000-2015) Report Developed by Tim O'Dowd - USFA/DHS

The U.S. Fire Administration's Campus Fire Fatalities in Residential Buildings (2000-2015) report analyzes the 85 fatal fires that took place in dormitories, fraternities, sororities and off-campus housing which resulted in 118 fatalities - an average of approximately seven per school year.
